### **Participant/Sponsor Instructions**

SALVETE, OMNES! Please review the registration form before distributing it to your student delegates and chaperones.

This is an expansion of the instructions included on the registration form itself. The following instructions to you will hopefully answer any additional questions that you or they may have about registration. If not, please reach out at <u>cascadiajcl@gmail.com</u> or (425) 296-9792.

If you or any students feel any symptoms of illness or sickness, please test before attending. If a positive test turns up, please contact us to let us know that you won't be attending. Masks are optional and at the participant's own discretion.

## **Registration and Submission Options:**

Sponsors, please send the physical registration forms via traditional mail in a <u>single envelope</u>. Sponsors may scan registration forms and send them to <u>cascadiajcl@gmail.com</u> in a single zip file. PDFs will only be accepted from school sponsors. Students who are members of attending delegations, must submit registration through their chapter/school's sponsor/attending teacher.

#### **Registration Instructions:**

- 1. Please *print neatly* in blue or black ink **OR** digital copies clearly scanned if not filled out on computer.
- 2. All forms must bear a signature. Typed signatures on physical registration forms will not be accepted.
- 3. All adult chaperones/parents/guardians **must register** alongside their student to ensure we have a proper headcount.

- 4. Members of an attending delegation registering digitally, must print the last two page of this document for the student's sponsor to submit with fee payment attached. At-large members registering digitally must print the last three pages of this document and enclose with registration fee payment.
- 5. Please email the state chair to receive approval to submit registration fees at check-in if registration fees cannot be mailed by March 1, 2024. If the registration fee causes hardship, please reach out to the state chair for scholarship options. Scholarships are limited, offered on a first-come, first-served basis and need based.
- 6. Registration fees are for students only. Supervising parents/chaperones are not required to pay the \$50 registration fee.
- 7. Shirts are included with registration for both student and adult chaperone/supervising adult. Chaperones/guardians may decline shirts. All students will receive shirts.
- 8. Checks may be made out to Cascadia JCL.
  - a. Sponsors, if you are collecting checks to give to your school for further processing, please let us know if your school needs to be invoiced and our treasurer, Rick Winterstein will be in touch.
  - b. Sponsors, if you are collecting checks, they should be made out to **Cascadia JCL** and <u>enclosed and attached to physical registration forms or the final page of this document.</u>
- 9. Please have your students and chaperones return their forms to you rather than sending them to us. Please verify forms for completeness and accuracy and make copies for your records before you send them to us.
- 10. Late registrations will only be accepted on a space-available basis. Please check with us that space is still available before sending in late registrations. There is a nominal late fee of \$5 for registrations postmarked after March 15, 2024. Hopefully, this encourages the 'fence-sitters' in your chapter to commit by the deadline. At the same time, we understand it may be difficult to find enough chaperones who can commit by the March 1, 2024, deadline. In that case, please simply let me know how many chaperone spaces you want to reserve. Delegations are required to provide at least 1 adult chaperone for every 10 youths.
- **11. Digital registration will remain open until March 15, 2024.** A \$5 registration late fee will be implemented for any registration forms received after March 1, 2024.
- 12. For schools, please obtain a CERTIFICATE OF LIABILITY INSURANCE. This is a routine procedure for groups holding events at camps and conference centers. Obtaining one should be a mere formality. Your school's business office should be able to help you.
- 13. All participants must sign the liability waiver attached in the Registration Packet.
- 14. Included in this packet is a tentative list to help you and your delegates plan their convention activities. I will follow up with a schedule shortly. I will notify you if there are any major schedule changes. The convention staff will make every effort to conclude the convention by 8 p.m on Saturday.
- 15. Please have attendees note any other dietary requests or restrictions (vegan, gluten-free, etc.) Pizza lunch will be provided. Pasta and salad will be provided for dinner. Participants may bring their own food and snacks to store on-site.
- 16. Please be sure that your chapter and all of your delegates are registered with both NJCL *and* Cascadia JCL. Registration with each body is done separately. Registration instructions for NJCL are available at the website

(<u>njcl.org</u>). To register with Cascadia JCL, please download the registration form from the website (cascadia<u>jcl.org</u>). <u>Non-school affiliated participants are not included expected to fulfill this requirement.</u>

# WAIVER AND RELEASE OF LIABILITY FORM

I understand that these injuries of outcomes may arise from my and/or Minor Child's own or others' negligence, conditions related to travel, or the condition of the Activity location. Nonetheless, I agree, personally and on behalf of Minor Child, to assume all related risks, both known or unknown to me, of my and/or Minor Child's attendance and/or participation in this Activity, including travel to, from and during this Activity.
It is my intention by signing this Waiver and Release of Liability Form to exempt, release, indemnify and hold harmless the Sponsor and the School of and from any and all claims (except claims for gross negligence), suits or actions of any kind whatsoever for all liability, property damage, wrongful death, compensation or otherwise brought by me individually or on behalf of Minor Child or anyone on our behalf, including attorney's fees and any related costs if litigation that arise pursuant to any claims made by me, Minor Child, or by anyone else acting on my behalf.
